Commissioner Linke noted that October 1, 2018 was the 15th employment anniversary of EMS Chief Ray Jennings.

Economic Development Director DiAnn Butler stated that she has officially heard that the County has received the Space to Create grant.

Grand Lake was picked as the regional area for the nine regions that are being done throughout the state for affordable live/work space for the creative economy. There are nine projects in eight regions throughout the state and they will be investing about \$45 million statewide.

The Becher Foundation will give the community \$285,000 for live/work space. The \$45 million will be used for nine projects throughout the state.

Commissioner Cimino moved to approve and enter into a Contract with Pictomotry International Corporation with a total amount of the Contract of \$587,324.50 and this is subject to annual appropriations. The Contract is effective September 30, 2018.

The Letter of Credit expires on September 9, 2026 and for the Board to accept a Surety Bond in the amount of \$25,000 and the details to be placed in the Resolution. The Resolution will be approved next Tuesday.
