Road and Bridge Superintendent Chris Baer stated that the roads are primarily snow packed and crews are plowing as needed. The crews are working on snow catches.

There was a water main break on top of County Road 84/834. The road has been repaired.

Katherine Morris, Grand County Water Quality Specialist, presented a contract to be signed for 2017. Partners with River District, Town of Winter Park, etc. Grand County's cost is higher than the others. Well within the budget. We pay Northern Water.

Commissioner Cimino moved to approve and authorize the Chair to sign the Agreement Shared Funding – 2017 Macroinvertebrate Monitoring between Grand County and Northern Colorado Water Conservancy District, the City and County of Denver acting by and through its Board of Water Commissioners, Colorado River Water Conservation District, Colorado River Headwaters Chapter of Colorado Trout Unlimited, Winter Park Water and Sanitation District, and the Town of Winter Park.

Discussion: Grand County's portion of this \$3,029.45. That is more than the other funding partners

for this year. Northern Water is the fiscal agent. This is an annual Agreement.

On November 23, 2017, we issued an RFP for an IP Based NG9-1-1 System and Selected Options for the Grand County Sheriff's Office Communication Center. We received two responses that were opened on December 18, 2017 from Motorola CallWorks and Solacom Guardian. Our evaluation of both vendor's responses included support services, price, reliability, a staff demo, functionality, graphical user interface, training, mapping, and reporting services.

The Board supports this request and directed staff to move forward with this project.

The Board recognized Peter Rempel for 20 years of service for Grand County.

Background

History:

Innsbruck-Val Moritz Subdivision was originally platted in 1973. The subdivision is comprised of numerous blocks and lots in the Granby area. Utility easements of 10 feet exist along all side and front lot lines within this subdivision, with dedication to the HOA. In 2008, Lots 48-50 went through an AFP process in order to divide lot 48 and combine each half to lot 48 and 50. Residences were built on Amended Lot 48 as well as Lot 46 and Lot 47 has remained vacant.

Project Description:

The applicants are proposing an Amended Final Plat that will divide Lot 47 and combine each half with Lot 48 and Amended Lot 48. The applicants purchased Lot 47 together with this intention. This will increase the yard space of each lot and will not cause an increase to density, as there are already existing residences on both lots.

The existing utility easements are dedicated to the Val Moritz Homeowners Association and the land is being combined with previously developed lots, therefore no utility vacation is required with this application. If the owners plan to build accessory buildings over the easements at a later time, they will need to request a resolution approving the vacation of the Utility and Drainage Easement by the Silver Creek Master Homeowner's Association.

Planning Commission Review

Unanimously recommended for approval by planning commission with the added condition that a quit claim deed be recorded to combine the legal descriptions for the two lots.

Recommendation

Staff recommends approval of Amended Final Plat, Lot 46A & 48 A, Block 17, Innsbruck Val-Moritz, A Replat of Lots 46 & 47, Block 17, Innsbruck Val-Moritz, Reception No. 127907, & Amended Lot 48, Block 17, Innsbruck Val- Moritz, Reception No. 2006-003252 and the consolidation of these lots with the following conditions:

- Notes for each 20' easement shall be corrected to read as follows:
 "20' UTILITY & DRAINAGE EASEMENT, RECEPTION #127907, VACATION WILL REQUIRE RESOLUTION FROM SILVER CREEK MASTER HOMEOWNERS ASSOCIATION"
- 2. Address for Lot 46 shall be corrected to read "659 GCR 899."
- 3. Title commitment numbers to be added to Note 1(b) on plat.
- 4. Dedication to be corrected as follows:
 - KNOW ALL MEN BY THESE PRESENTS: That Jack A. & Claire A. Stiegelmar and Stephen Robert & Susan Carol Morrison are the owners of that real property situated in Grand County, Colorado, more fully described as follows:
 - Lots 46 & 47,Block 17, Innsbruck-Val Moritz, Reception No. 127907 & Amended Lot 48, Block 17, Innsbruck Val-Moritz, Reception No. 2006-003252,County of Grand, State of Colorado That they have caused said real property to be laid out and surveyed as Amended Final Plat, Lot 46A & 48A, Block 17, Innsbruck Val-Moritz, and do hereby dedicate and set apart all the roads, streets, alleys and other ways and places shown on the accompanying plat for the use of the public forever; and does hereby dedicate those portions of said real property which are created as easements on the accompanying plat to the use of the public forever as easements for the purposes shown hereon, unless otherwise expressly provided thereon; and do hereby grant the right to install and maintain necessary structures to the entity providing the services for which the easements are established.
