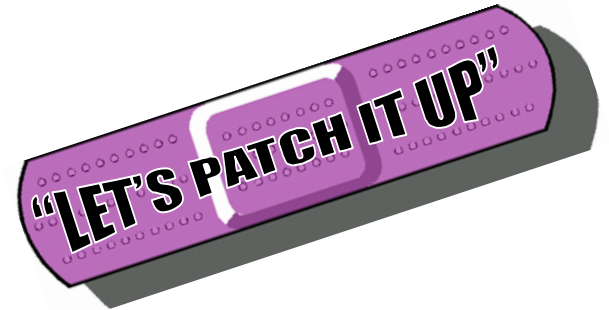

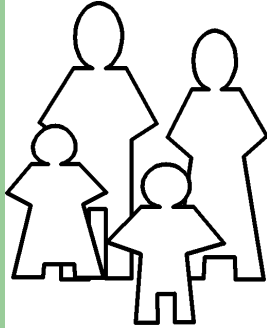

Program Eligibility

Families with children under the age of 18 who are without insurance, Medicaid**, or CHP+ and meet the income requirement.

**Children with Medicaid or CHP+ in need of dental care can still qualify for dental vouchers, only.

Voucher Qualifications

To receive services under the program you must be screened by a nurse. The child must have an acute, non-emergent illness (like fever, sore throat, achy body, etc).

Limit of **3 vouchers** per year per family.
Cost of \$10 per voucher.

This program does **NOT** cover long-term, on-going conditions or emergency room care.

This program is **NOT** an insurance program.

Conditions Not Covered

- *Annual or sports physical
- *ER visits
- *Annual dental exams or dental maintenance
- *Annual vision exam or glasses
- *Refill medications
- *Pregnancy or birth control

Mobile Vans

In addition to offering vouchers for services we are now offering mobile vans, in collaboration with **Rocky Mountain Youth Clinics**.



Mobile Van Services

Medical Van:

Well Child Checks, Immunizations, Sports Physicals, Education & Referrals.

Dental Van:

Well Child Checks, Fluoride Varnish, Sealants, Education & Referrals.

Vans visit Grand County every Spring and Summer. Please call for more information.

Cost is \$10 per child per visit.
