Notice of Intent to Redeem must be filed within 8 business days after the sale [can be more than 8 days if they meet 38-38-302(1)(D)] and include the following:

- A. Payment of the \$50 fee.
- B. The original or certified copy of recorded document showing right to redeem. If an original instrument is provided we will make a copy and return, retaining the copy for our records.
